The State of our Schools Report, published in 2013, 2016 and 2021, compiles and analyzes the best available school district data on public school facilities expenditures and debt from across the U.S. The past three reports have consistently found that the PK-12 public facilities sector, which is second only to highways in infrastructure spending, faces an alarming investment gap, which increased from \$46 billion in 2016 to \$85 billion in 2021. Each report provides critical information and analysis into the nation's PK-12 school facility infrastructure, including the devastating impacts of this chronic underinvestment.

Further, as the only analysis of its kind, the report's findings have been at the very center of the national school infrastructure conversation. It has shaped government policy and investment decisions at all levels of government, from the halls of the Capitol to states and school districts around the country. But the state of PK-12 school facilities continues to shift. Over the last two years, since the 2021 report, there is a deepening awareness of the structural inequities in our nation's public school facilities, by income and race. There is a better understanding of climate related vulnerabilities of our communities and schools. Finally, the shared trauma of a global pandemic has highlighted an array of health threats and hazards associated with the longstanding neglect of our public school facilities. Given this changing landscape, the need has never been more urgent to update and add to our understanding of the state of our schools and their impact on health and equity.
